



**Eli Weinberg** went to South Africa from Latvia in 1929 and lived there working as a professional photographer until 1976 when he left the country illegally and was given political asylum in Tanzania.

While he was in South Africa he was an active trade-unionist and supporter of the liberation-movement. The 200 photographs in this book are his record of the movement for freedom in South Africa. They cover key issues and events which occurred between the mid-forties and the early sixties. The character of both the Struggle against apartheid and the people involved in the liberation movement emerge from these pictures. They show that a deep-rooted resistance movement against apartheid has always existed and continues to exist in South Africa; that his movement has well-considered directions and objectives; and that at every stage of its development it has had, and continues to have, the loyal and enthusiastic support of the majority of South Africans.
